10. Any Other Business

Knott Lane – Cumbria Wildlife T rust are interested in creating a wildflower corridor along Knott Lane in conjunction with Westmorland Dales Landscape partnership, Calum Stott gave us a run down of the proposal, it was noted that work would need to be done to the lane before proceeding, raised manhole covers, brash and stone would need sorting. There would be no possibility of grazing the lane. Grass cutting would need to be done after flowering and the cutting removed, the amount of hay would be minimal so no charge could be made for this but someone would need to be enlisted to do the work. The proposal itself was looked on with approval.

Howes Carpark – Planning has come through for the new gate and pedestrian access. No gate can be left on the roadside entrance but a temporary hurdle could be used to manage stock when necessary. When the carpark goes live a sign will need to be erected 'Cars parked at Owners Risk'.

Land at Park Lane – Mark Mawson confirmed he would sort the fence out prior to the commencement of the new Grass Letting on 1st May.

Tree to rear of Chris and Mary Jenkin's house, it was agreed that we would get some quotation for removal of overhanging branches, planning permission for works to trees in a conservation area would be required prior to any work taking place.

Plot of Trees on Appleby Road – After discussion it was decided that the plot being referred to was on the corner higher up than the Scots Pine plantation, these will be looked at as may need thinning.
